About the Festival

The Annual Rattlesnake Festival began in 1967 as a small Jaycee project in San Antonio, Florida. In 1973, arts and crafts were added as an important part of the event. This festival is attended by more than 10,000 people. People come to visit and take part in the food, arts & crafts, live music, wildlife, children's games, and local history that are highlighted at the festival. Profits from the festival benefit The Thomas Promise Foundation, an organization that provides weekend lunches to food-insecure students.

This year we are adding an evening pre-festival concert on Friday Oct. 18 featuring the Bellamy Brothers and a different event or concert on Saturday evening. You will still be able to set up on Friday but will be required to purchase tickets if you wish to attend either of the concerts.

Past vendors note that Saturday has been extended to 6 p.m. and Sunday has been extended to 5 p.m.

Dates & Times: Pre-Festival Concert: Friday Oct. 18, 2019 - 7 to 9 p.m.; Festival: Saturday, Oct. 19, 2019 - 9 a.m. to 6 p.m.; Saturday Evening TBA Event/Concert approximately 7 p.m. to 10 p.m.; Sunday, Oct. 20, 2019 - 10 a.m. to 5 p.m.

Set-up Time: **Friday, Oct. 18 between 12 and 6 p.m.** and **Saturday, Oct. 19 until 8 a.m.** Vehicles **must** be unloaded and taken to Vendor Parking before setting up your spot to make room for others bringing in their materials. All vehicles must be out of the festival grounds by 8 a.m. on Saturday.

End of Day: We expect vendors to remain "open" until 6 p.m. on Saturday and 5 p.m. on Sunday. No vehicles will be admitted onto the festival grounds until the festival closes each day.

Sunday Morning: Vehicles must be removed from the festival grounds by 9 a.m. on Sunday.

Take Down Time: No vehicles will be allowed on the festival grounds until 5 p.m. on Sunday.

Exhibit Space: 10' x 10'

Fee: \$200 for both days

Security: A paid security guard will be on duty Friday and Saturday nights.

Sales Tax: Collection of appropriate Sales Tax is the responsibility of each Vendor.

Insurance: Vendors including hands-on activities for attendees must file a copy of their Certificate of Insurance with the Festival office.

Deadline: There is no deadline as such, we will take business vendors as long as we are able to accommodate them, but keep in mind that this is a first-come-first serve arrangement. We do not expect that we will run out of room for business vendors, but it is best to submit your application at your earliest convenience. Acceptance and placement of vendors is determined solely by the Festival Committee.

BUSINESS VENDOR POLICIES

The primary purpose of the Rattlesnake Festival is to provide fun and enriching family-friendly activities and to raise funds to feed food-insecure students through The Thomas Promise Foundation, a 501(c) 3 non-profit organization. Review the Thomas Promise mission at thethomaspromise.org. To maintain a high standard of quality for the Festival, you must agree to adhere to the following:

Items for Sale:

- No items using the official Rattlesnake logo may be sold (e.g., silk-screened or transfer T-shirts, hats or caps, etc.).
- Photographs of your display/booth and a representative sample of the items to be exhibited/sold must be submitted with your application to help us determine appropriateness.

Exhibit/Display Area:

- Items must be displayed in an attractive manner (subject to committee review). Please be prepared for all types of weather.
- Vendors are to supply their own tent, table(s), chair(s), and signage.
- Tables must be covered, and boxes, extra inventory, etc. must be stored out of sight.
- The Rattlesnake Festival Committee will conduct an inspection of your booth to ensure compliance. Inappropriate items will be required to be removed.
- If your entire exhibit is in violation of these policies, you will be dismissed from the show and may not be considered for future events.
- Vendors must staff their display/booth at all times during festival hours.
- State of Florida Health Department regulations must be adhered to, if relevant. The Health Inspector may be on the grounds and could shut down any operation not in compliance.
- Vendors are responsible for business wastes. Access to a dumpster on site to dispose of wastes will be provided. Public receptacles placed by the Rattlesnake Festival are not to be used.
- Vendor is responsible for knowing and complying with these regulations.

General Terms:

- Vendor must provide Certificate of Insurance with application, if applicable.
- No selling, transferring, or subletting of space. The space is to be used only by the name(s) that appear on the application.
- We will provide confirmation of approval of your application and other information by e-mail. If U.S. Postal Service communication is necessary, a self-addressed, stamped envelope must accompany the application.
- Please leave your area in the same condition in which it was found. Failure to do so could result in denial of application acceptance in future years.
- Receipt of application and fee does not guarantee a vendor space, as spaces are limited. An official acceptance notification will be e-mailed when fees have been received in the Rattlesnake Festival account (checks cleared, transfers completed, etc.) For applicants who are not selected for the Festival, the fee will be returned within one month of receipt. A paid and accepted reservation is a binding commitment to exhibit at the festival.
- No refunds, cancellations, or rain date.
- If you do not show or leave early you will not be considered for future festivals.
- By signing the application, you agree to obey all Vendor Policies.
